THE MARRIAGE CONTRACT

III. RECITAL

We, the above-named Bridegroom and Bride (hereinafter referred to as "the Husband" and "the Wife" respectively) DECLARE that this Marriage Contract is drawn and the provisions herein are agreed to on our free will and accord at the time of the solemnisation of our marriage.

IV. THE CONTRACT

- 1. We, therefore, the Husband and Wife, whose signatures are affixed herein, and professing the Shia Ithna Asheri Faith of Islam have agreed to take each other in marriage on our own free will and in accordance with the Laws of the Shia Ithna-asheri faith of Islam, and upon mutual love and compassion.
- 2. It is hereby agreed that MAHR of

______ shall be given by the Husband to the Wife prior to the consummation of the marriage or thereafter when demanded by the Wife.

- 3. It is hereby further agreed by both of us the Husband and Wife that the exchange of gifts between us as well as the gifts given to us individually by our respective parents, friends and relatives during the periods of engagement for marriage and matrimonial life shall always be and remain our respective individual properties and they shall not be subject to recall at any time even in the event of dissolution of marriage.
- 4. It is also agreed that the Husband delegates to the Wife irrevocable authority, if she so desires to exercise, to appoint an Agent (Wakil) for divorcing her on behalf of the Husband which right/authority can be exercised by her in the following circumstances only with the written consent of the Jamaat in the city/town where the couple have been resident or where the marriage has been solemnised, after having exhausted all possible-attempts for agreement for relief or elimination of the causes and effects of the circumstances concerned and which consent can be granted by the concerned Jamaat and / or Jamaat's Conciliatory Board or Committee without further reference to the Husband. (In cases where the respective Jamaat(s) has ceased to exist, the nearest Jamaat shall be considered as the contact Jamaat):
 - i. If the Husband at his own behest divorces the Wife in a civil court and does not give her Shar'ie Talaq (divorce) as required under the Sharia Laws.
 - ii. If the Husband is able but unwilling for four months and willing but unable for six months to consummate the marriage.
 - iii. If the Husband is proved to have become insane, incurably impotent, or has contracted incurable contagious disease, like (but not limited) to HIV/AIDS and/or leprosy.
 - iv. If there is medical evidence to prove that the Husband is addicted to illegal drugs and/or intoxicants (unless required as prescribed medication), to an extent that the Wife finds it unbearable to continue the marital relationship
 - v. If the Husband disappears or abandons the Wife or does not provide for shelter and maintenance to the Wife and children (if any) for six months continuously.
 - vi. If there is independent medical evidence that the Husband subjects the Wife to mental or physical abuses to an extent that the Wife finds it unbearable to continue the marital relationship.
 - vii. If the Husband demands and/or compels the Wife to perform major sin/s expressly forbidden in the Holy Qur'an.
 - viii. If the Husband abandons the Shia Ithna Asheri Faith of Islam.
 - ix. If the Husband is imprisoned for a continuous period of four years or more.

5. **OPTIONAL CONDITIONS PERTAINING TO DISSOLUTION OF MARRIAGE** I AGREE I DONOT AGREE If the Husband marries another woman in a permanent marriage without written permission of the Wife named in this Marriage Contract.

In situations other than the above where the Wife deems it necessary to seek a divorce, guidance be sought through the Jamaat and/or the Resident Aalim from a designated Wakil of the Marja who has been authorized by a Marja-e-Taqleed to deal with such matters.

VII. NOTES

A. Mahr

Minimum Mahr to be ascertained and set by the respective Jamaat from time to time as recommendation to the parties. It is recommended that payment of the Mahr be made prior to solemnisation of the Nikah or immediately thereafter.

B. Distribution of Assets

Assets owned before marriage by the Husband/Wife shall not be subject to any division or distribution in the event of dissolution of the marriage. Those assets acquired thereafter (in the course of matrimony) by the Wife through her own personal toil shall solely belong to her at all times

C. Explanation on Filling of this Contract

- 1. The Bridegroom and the Bride are required to personally and carefully read the terms herein stated in this contract, and where any sections are not understood they must contact a Jamaat Official for explanation and guidance.
- 2. Please fill and return these forms at least 7 days before the Marriage date to avoid last minutes delays and inconveniences.

D. Jamaat Administration

(Recommendation and Guidance to the Jamaat Officials involved in facilitating and conducting the Nikah)

- 1. Ensure that the Marriage Contract Forms are given to both parties for completion and signatures well in time at least seven days before the intended day for solemnisation of the Nikah.
- 2. Ensure that proper explanation and guidance is given to both parties on their respective rights and obligations relating to this Marriage Contract.
- 3. Ensure that the Marriage Contract is duly and fully filled and completed by both parties and signed by the witnesses also before the solemnization of the Nikah, retaining one original copy for Jamaat's record.
- 4. Ensure all the pages of the Marriage Contract are initialed by the Bridegroom (Husband) and the Bride (Wife), and the Jamaat Official.
- 5. Retain good legible Particulars Page copy of the passport or national identity of the Bridegroom (Husband) and Bride (Wife) along with the signed Marriage Contract form.
