## TERMS AND CONDITIONS

These are the Terms and Conditions for The World Federation of KSIMC (TWF)'s Khoja Heritage Tour (KHT). TWF is the facilitator and organiser for this tour. All participants must comply with TWF's terms and conditions in order to take part.

- **Risk Statement**

TWF shall not be liable for any injury, illness or death of any person resulting from the participant's negligence. TWF shall not be liable for any loss or damage to property or any indirect or consequential loss however arising.

- **Payment of Fees**

Registration for the tour is confirmed (if the conditions of participation are met) on receipt of tour fees which can be paid until 30<sup>th</sup> Nov 2023 to avail the early bird offer i.e., US\$ 1,249 (or GBP 1,025) , after which the tour cost will be US\$ 1,449 (GBP 1,175).

- **Conditions of Participation**

To take part in this tour participants must:

1. Be a member of a registered Khoja Ishna-Asheri Jamaat.
2. Complete and submit the tour application form.
3. Have two Covid-19 vaccinations as required by the law of the land.
4. Apply for any relevant visas or any other travel documentation, at their own expense.
5. Have adequate travel insurance, which must cover emergency search and rescue and medical expenses.

**We advise participants to take out cancellation insurance.**

- **Participant's Responsibilities**

1. Please consult your GP for anti-malarial and travel vaccine.
2. Submit a scanned copy of your passport and proof of 2 doses of Covid-19 vaccination along with the registration form.
3. In case of refused passage and/or entry/exit to or from any of the countries, any additional costs incurred will be the participant's responsibility.
4. If a participant does anything to void their insurance, including not declaring any pre-existing medical condition/s, they are fully responsible for paying any and all associated costs including travel and accommodation to and from the departure/arrival point in India.
5. Participants must observe modest clothing as prescribed by the Shariah during the tour.
6. Should the participant have to withdraw at any time, they will need to inform TWF by email. No refunds will be provided as most bookings are non-refundable.
7. Baggage and personal effects are at owner's risk throughout the tour. Luggage weight restrictions will be provided in your itinerary.
8. While utmost care will be taken to choose the best of accommodation as per the package cost, participants are expected to stay at the chosen accommodation and not ask for upgrades.

- **General Information**

1. The cost of tour includes only the ground package, the rest needs to be borne by the participants themselves.
2. TWF has the right to subcontract any of its services to any third-party service providers at its sole discretion.
3. The participant understands and accept that itineraries, schedules, and accommodation may change, and other alterations may occur which are beyond the control of TWF or any supporting service provider.
4. TWF reserves the right to increase the price of travel arrangements to allow for reasonable variations in transportation and accommodation costs.
5. TWF may at its sole discretion change routes or withdraw places on the challenge event.
6. Should the event be cancelled due to government restrictions or any other reason, we will communicate this to you and explore options available.
7. TWF will assist with promoting the activity.
8. TWF may use photos of participants or correspondence for media purposes having sought express approval from participants.
9. The participant understands and accepts that neither TWF nor the participant will be able to claim Gift aid for travel and accommodation costs incurred by either parties.

- **Data Protection**

Any personal information requested by TWF is held on paper and digitally. Any personal information you send to TWF will be processed in accordance with the Data Protection Act 2018 and the General Data Protection Regulations 2018.

- **Governing Law and Jurisdiction**

Any contract between the participant and TWF shall be governed in all respects by English Law. Only English Courts shall have jurisdiction in relation to any claim or dispute arising out of or connected with any such contract.
