ORDER

UPON the final hearing of the Part 8 claim herein (“**the Claim**”) taking place before Nicola Rushton KC (sitting as a Deputy Judge of the High Court) between 21 November and 1 December 2023 at the Business and Property Courts, 7 Rolls Buildings, Fetter Lane, London EC4A 1NL

AND UPON the Court handing down its written judgment on the Claim

IT IS ORDERED THAT

- (1) The Claim is dismissed.

- (2) Pursuant to CPR Part 52 rule (2) (a) the time for filing any appellant's notice at the Court of Appeal is extended to the date 21 days after the conclusion of the hearing referred to in paragraph (3) of this Order.
- (3) The determination of matters consequential on the dismissal of the Claim (including, for the avoidance of doubt, orders for costs and for payment on account of costs, any application for permission for appeal and any application relating to confidential documents) is adjourned to a hearing before Nicola Rushton KC (sitting as a Deputy Judge of the High Court) on 25 March 2024, with a time estimate of half a day. The hearing will be in person, with a hybrid facility by MS Teams.
- (4) Any skeleton arguments for the adjourned hearing are to be filed (by CE-filing and emailing direct to the judge or her clerk) and exchanged by 4pm on Thursday 21 March 2024 and limited to 15 pages.
- (5) This order shall be served by the Claimant on the Defendants.
